A Public Hearing was held on November 9, 2021, at the Municipal Building at 858 Main Street, Sugarloaf, Pa. at 7:45 PM. The purpose of this hearing was for the Supervisors to consider public comment on a LERTA Application from Crossroads XOX, LLC. The meeting was advertised in the Standard Speaker on October 29, 2021.

Attendance: In attendance were Chairman Rick Weaver, Supervisor Richard Yost, and Supervisor Joseph DiSabella. Also in attendance were Atty. Ferdinand., Zoning Officer Henry Mleczynski and Township Office Manager Elizabeth Tolan. For the applicant in attendance to provide testimony were Atty. Catherine N. Durso of Fitzpatrick Lentz & Bubba, P.C., and Mr. Jim Vozar from JVI.

## Pledge of Allegiance

Opening Comments from Atty. Ferdinand: Atty. Ferdinand entered Exhibit #1 Advertisement for Hearing, Exhibit #2 Application of Crossroads XOX, LLC and Exhibit #3 Power Point Presentation JVI on behalf of Sugarloaf Township into the record and advised those present at the hearing of the scope of approval which was being considered at the hearing as far as the LERTA application.

**Applicant Testimony:** Atty. Durso gave an overview regarding the application and mentioned that the scope of the project seeking LERTA spanned several municipalities. She also mentioned that Hazle Township had approved the LERTA application for the portion of the project in their municipality.

Mr. Vozar gave a detailed summary of the condition of the property currently, plans for the property, and explained the many steps that still had to be completed regarding evaluating the site and preparing it for building.

<u>Comments from Atty. Ferdinand:</u> Before opening the floor to public comment, Atty. Ferdinand offered the Supervisors an opportunity to ask any questions they had. The Supervisors questions and comments were recorded by the township recording system and are a matter of public record.

<u>Public Comment:</u> The floor was then opened for questions to Mr. Vozar, and then for Public Comment to the Supervisors. There was no public comment.
