# RESOLUTION NO. 6 OF 2023 MUNICIPAL FEES

WHEREAS, the Board of Supervisors of the Township of Sugarloaf, Luzerne County, Pennsylvania is meeting in a duly authorized assembly, as follows: and

THEREFORE, be it resolved and enacted that the Sugarloaf Township Supervisors set the zoning permit fees for 2023 as follows:

Zoning Permits are required for the following:

A) New Single Family Residential-Principal and Accessory Structures:

\$75.00 Initial Inspection / \$50.00 Each Follow-up Inspection

#### I) Repairs to Existing Structures (Residential)

J) Repairs to Existing Structures (Non-Residential)

### K) Sign Permit Fees:

- 1. \$75.00 Up to Four (4) Square Feet
- 2. \$10.00 per Square Foot for Each Additional Square Foot
- 3. Existing Permitted Sign Face Replacement in Kind \$100.00 per Sign
- 4. Under this Fee Resolution, no annual fee will be charged. All Sign Permits will be a one (1) time fee except in the case of a sign face replacement.

## L) Road Occupancy/Driveway Permit

#### M) Central Sanitary Sewer Permit

- The Central Sewer Tap-On Fee for all sewer districts in Sugarloaf Township is \$2,800.00 per EDU, plus any portion of an EDU. For example, if the flow rate from a new project is determined to be 2.45 EDU's, the fee would be calculated as follows:
  - $2 \times \$2,800.00$  plus  $0.45 \times \$2,800.00$  for a total of \$6,860.00 for the Tap-On Connection Fee which includes a Tap-On Inspection of \$140.00. Any additional work pertaining to Central Sewage will be billed at \$70.00 per hour.
- Central Sewer Repair Permit (All Districts) \$120.00 (Includes one (1) final inspection).
   Refer to Permit for Paving Agreement.

### N) Ordinance Books

The Zoning Ordinance Book, Subdivision and Land Development Ordinance (SALDO) Book, and Storm water Management Ordinance Book will each be sold separately for \$30.00 per copy (Pick up at the Township Office) or \$50.00 per copy (mailed). Payment is required in advance. Zoning Maps available for \$25.00.

#### O) Solicitors and Peddlers Permit

\$50.00 for a Thirty (30) Day Period (No Soliciting on Sundays)
