The Sugarloaf Township Supervisors held a Special Meeting on Tuesday, October 24, 2023 at 5:15 PM at the Municipal Building, 858 Main Street, Sugarloaf, PA 18249. The meeting was duly advertised in the Standard Speaker on October 23, 2023. The purpose of the meeting was for the consideration of Resolutions to apply for Grants for the improvements of the existing stormwater swale between Royal Crest and Klinger Estates, the Prospect Road Stormwater Improvements Project, and the Lamar Development Stormwater Improvements Project and for any other business that the Supervisors would like to discuss.

New Business:

Resolution No. 16 of 2023:

Resolution No. 16 of 2023 to apply for a State LSA Grant at the recommendation of the Township Engineer for Stormwater improvements for the Royal Crest/Klinger Estates was presented to the Supervisors for consideration. A motion was made by Supervisor Yost, seconded by Supervisor Weaver, to approve Resolution No. 16 of 2023. The motion passed unanimously.

Resolution No. 17 of 2023:

Resolution No. 18 of 2023:

Resolution No. 18 of 2023 to apply for a State LSA Grant at the recommendation of the Township Engineer for Stormwater improvements of the Lamar Development was presented to the Board of Supervisors for consideration. A motion was made by Supervisor Yost, seconded by Supervisor Weaver, to approve Resolution No. 18 of 2023. The motion passed unanimously.

Jan and Barbara Pasdon addressed the Supervisors with concerns about Stormwater on their property at 51 Prospect Road, Sugarloaf, PA 18249. The township will request their Engineer Denny Peters to try to meet with Heather Graham from the Luzerne County Conservation District at the site for any suggestions.

Moira Dagostin addressed the Supervisors. She questioned the reason for the Electronic Speed Sign on Rock Glen Road. Supervisor DiSabella stated that it is gathering data of times and speed. She also mentioned that guard rails are missing on Rock Glen Road. This resulted from a vehicle accident a short time ago. The possibility of checking into the driver's insurance company having to pay for the damage is being considered. Information will be gathered in regards to this matter.
