SPECIAL MEETING MINUTES  
Friday October 25, 2024

The Sugarloaf Township Supervisors held a Special Meeting on Friday, October 25, 2024 at 8:00 AM at the Municipal Building, 858 Main Street, Sugarloaf, PA 18249. The meeting was duly advertised in the Standard Speaker on Tuesday, October 22, 2024. The purpose of the meeting was for the opening of Bids for a Street Sweeper for the road department, and for any other business that the Supervisors would like to discuss.

In attendance were Chairman Joseph DiSabella, Supervisor Rick Weaver, Supervisor Richard Yost and Administrative Assistant Lori Webster.

**Additions to the Agenda:**

A motion was made by Supervisor Yost, seconded by Supervisor Weaver, to add the following items to the agenda:

1. Resolution NO. 16 of 2024: A resolution authorizing the Slusser Law Firm to initiate an action in equity (Declaratory Action, Quiet Title Action, Ejectment, and other theories as appropriate) for the takeover of the Private Sewer Line Purportedly owned by AHDP.
2. Resolution NO. 17 of 2024: A resolution approving the services of CBIZ INR ADVISORY SERVICES for the investment management of a 457b plan for employees.
3. Selection and approval of a date for advertising a Work Session for the 2025 Budget.

**Opening of Bids:**

Supervisor Yost opened bids received for a street sweeper for the road department. There was only one bid received. That bid was from Blue Ridge Iron, LLC. Supervisor Weaver and Road Foreman Duane Hildebrand inspected the bid to make certain that it met the advertised specifications.

A motion was made by Supervisor Weaver, seconded by Supervisor Yost, to accept the bid for the purchase of a street sweeper from Blue Ridge Iron, LLC at the cost of \$66,000.00.

The motion passed unanimously.

**Resolution NO. 16 of 2024:**

A motion was made by Supervisor Yost, seconded by Supervisor DiSabella, to approve the work session to be held on Friday, November 8, 2024 at 8 am.

The motion passed unanimously.
